

1. LEGAL INFORMATION

1.1 Web editor

2. PERSONAL DATA PROTECTION

Pursuant to Article 22 of law No. 78-17 dated January 6, 1978, modified by law No. 2004-801 dated August 6, 2004, the processing of personal data collected or published on the Website are covered by the CNIL’s (the French Data Protection Authority) dispensation of registration No. 7, related to “processing in connection with information and external communication purposes”.
